Dear Angela Wild [sister]/[daughter]

It has come to my attention today via this Court Order linked here <http://opg.me/ClarkeAnn10370284order110416.pdf> that you did file an application on the 21st March 2016 that, in a previous court order from JUDGE Jackson on the 22.2.2016 he, Jackson did incite you to do with **legal advice**, to make such an application, here in this linked order, from that date paragraph section No.2 <http://opg.me/Clarkejudgment22.2.16.pdf> .

In view of the above, being your formal intention to attempt theft of a 3rd property from your mother, and also the abduction/theft of your mother from a foreign land against her wishes that have been repeated today by her, I now see no alternative but to formally expose your previous theft upon your own mother by way of an EXECUTOR demand for payment of outstanding monies owed to your mothers estate of £4950.00 with immediate effect.
